• Land Use Policy Discussion/Decision (Frisbee Golf) Pertinent History listed below:

Bill doesn't want to hold an actual event, but rather let people use his equipment (frisbee golf baskets) for free on Saturday afternoons while the weather is good. (Joel)

We will need a separate endorsement for this activity on the open space. He is sending a questionnaire that has to be completed by us, then he has to submit the request to

our insurer, Non Profit Insurance Alliance to find out what the premium will be and it may take up to 3 weeks to have the endorsement in place. Our agent also asked if Bill has insurance for the golf disc event. Can someone please contact Bill and ask him not to set anything up until we can figure this out? I don't have his contact information. I actually think this needs to be discussed at a future board meeting. Our insurance agent also strongly advised that we not do any night time activities on the open space; our insurance may reject coverage due to greater potential liability of injuries. (Debie)

I have reviewed the bylaws and there is clearly nothing that would preclude frisbee golf, or the transient installation of frisbee golf baskets or whatever. My previous opinion on the subject -- that allowing that activity had the potential to open us all up to uninsured liability -- was my gut reaction based on my long-instilled lawyer's risk/reward calculus = there is no real benefit to the open space in allowing frisbee golf, and there is a potential downside (albeit minimal), so why allow it? (Jeremy)

It does occur to me, however, that the fundamental problem is that Bill asked permission ... proving once again that it is better to beg forgiveness than ask permission. I know it's the right neighborly thing to do and all, but this is an open space, and we have no troops to employ in policing unauthorized uses of it, as amply demonstrated each July 4 and most Saturday nights. If we affirmatively say he can use the space for frisbee golf, and someone turns an ankle on the 17th fairway, I think it is true that person might be able to successfully sue SKOS for authorizing an activity for which it is not insured, and not providing safe premises for that activity. But if he and his frisbee posse want to take advantage of a large field open to the public to play disc golf on the weekends ... well ... that seems like their problem.
